<u>TeamViewer</u> [17] is a computer software package for remote control, desktop sharing, online meetings, web conferencing and file transfer between computers. TeamViewer can support Microsoft Windows, Mac OS X, Linux, Chrome OS, iOS, Android, Windows RT, Windows Phone 8 and BlackBerry operating systems. It is also possible to access a machine running TeamViewer with a web browser. This program is good for remote control of computers, collaboration and presentation features.

For technical support we may ask if you could install the 'Quick Support' or 'Host' program on your computer or application on your android phone. If so you can get the application from TeamViewer.com [18] or below we have links to a branded version and app stores.

Domain Registration

Cocoa Village Publishing is an authorized reseller of domain registration for TUCOWS/OPENSRS, however we can provide consultation for you to register a domain name with other registrars providing that the registrar has adequately documented procedures.

OpenSRS Retail Pricing:

For our customers that pay in advance for hosting <u>Internet Services</u> [5] we renew the base domain name annually at no additional cost. For your domain names you can arrange to have the name registered for up to a maximum of ten years into the future according to the <u>ICANN</u> [27] policy.

We do have customers who purchase additional registrations or registration only. As a reseller for OpenSRS **as of Summer 2017** for domain registrations not included in a package we are adjusting our prices to be \$13 more than the OpenSRS wholesale price with a compounding discount of a dollar for each additional year paid in advance up to a maximum of ten years in advance. For example if registering and additional name or separate from hosting and the OpenSRS wholesale price is \$11/year (.com) then our retail price is 11+13=\$24 year but, with a discount of one dollar for each additional year purchased (ten years in advance would be \$195.00=24+23+22+21+20+19+18+17+16+15).*

FAQ

Q. Is your service automated, do I have to fill out a form somewhere to use your service? **A.** No, pick the phone and call us or <u>message us</u> [30] and we as humans will answer the questions and enter the necessary information and changes on your behalf. We made the decision to use the KISS approach and not automate everything. Takes a little more effort, but avoids the problems that automation can cause.

Q. Why use a TUCOWS/OPENSRS reseller like you [31] to register or renew domain names? **A.** Tucows/Opensrs has a good reputation and they are an <u>accredited registrar</u> [32], they support their resellers efficiently and promptly without long holds, they use <u>open source</u> solutions [33], you can go direct to their <u>simple web interfaces</u> [34] to change information and if the need arises you can request to switch resellers while keeping the same registrar.

Q. Why does it cost more than some other registrars?

A. Sometimes the wholesale cost of using Tucows/Opensrs to the reseller is more than some discount registrar sites offer, so our retail cost has to be more. We have considered signing up to resell for some discount registers, but decided not to because the support was not adequate in many cases (many discounted registrars don't have a phone listed, or you get busy signals, on hold and no return to messages left at their voice mail) and in the past we have assisted customers who have had unsavory experiences with their domains that were registered by bulk discount registrars and had to resort to legal action to correct. Sometime you get what you pay for.

Q. Could we become a reseller myself for Opensrs/Tucows and avoid the added retailing fee? **A.** Why yes you can, but do you really want that overhead? If you have a few names, definitely not. The answer may be yes if your company needs to support a lot of domain names, outsource some of your support and you want direct access for your MIS or computer department. You will need to meet some minimum requirements, fill out a lot of paperwork, properly post your resellers information for public viewing, and probably put down a monetary deposit to qualify. For a nominal consulting fee we can help you set up this service internally. Call or contact us if this is something you are interested in.

Q. I used a different registrar, can you still support me?

A. Yes in most cases, however we could not directly handle billing for the name on your behalf, to make changes on your behalf we would need appropriate authorization granted, and if excessive labor is involved in making changes for that registrars settings we would need to ask for a nominal labor fee.

Domain Registration Limitations:

- Domain names use only letters, numbers, or hyphen ("-")
- Cannot begin or end with a hyphen
- .com, .net, .org and .info domain names should not exceed 67 characters total and may not be accepted if so by registration services.
- .info must have at least 3 characters not including .info
- · Domain names are not case sensitive
- Domain names cannot include spaces

Classic Domains that have been in use for a long time and viewers will be familiar with are listed below. We recommend when possible to reserve a *.com name because most viewers are familiar with that naming way.

us, biz, com [36], info [37], name, net, org [38]

.us is the country code top level domain name (ccTLD) designated for the United States of America. It was established in 1985. The registry is operated by an American company, in the United States and overseen by the Department of Commerce.

.biz is a restricted gTLD approved by ICANN in 2001. The .biz TLD is the first TLD dedicated to the needs of businesses worldwide. In order to register a .biz domain the registry requires that the site be used for business purposes.

.info is a gTLD approved by ICANN in late 2000. The .info TLD is not restricted by purpose

.com is an existing gTLD that was around before the creation of ICANN. The name was originally intended for commercial usage, but is now commonly used for any purpose and is not restricted.

.net is an existing gTLD that was around before the creation of ICANN. The name was originally intended for technical usage like networks, but is now commonly used and is not restricted by purpose.

.org is an existing gTLD that was around before the creation of ICANN. The name was originally intended for usage by organizations, but is now commonly used and is not restricted by purpose.

.name A generic Top Level Domain (gTLD) that became available in January 2002, designed specifically for individuals. **.name** is a space on the Internet that provides people with the ability to create their own digital online identities.

WHOIS [39]

WHOIS is a tool that is used to look up records in a Registrar database. Each record within the Registrar database has a "handle" (a unique identifier assigned to it), a name, a record type, and various other fields. The WHOIS service provides a means for searching on these specific fields.

To use WHOIS for a domain search, simply type in the domain you are looking for. This domain must be a second-level domain, for example "example.com". Domains with a "www" or third-level domains like "my.example.com" are not contained within WHOIS. The default action for WHOIS is to only search for domain records, however you can do other types of searches by using specific keywords.

If the domain you are searching for is not contained within the Registrar's WHOIS database, WHOIS should access the Shared Registry System and the WHOIS services of other remote Registrars to satisfy the domain name search.

A note about WHOIS [39]:

With the new shared registration system model, the nature of the WHOIS server has changed. Traditionally, the InterNIC maintained the WHOIS server for .com, .net and .org domain names, and a single query returned full whois data including registrant, administrative contact, billing contact, technical contact, and nameserver information. Under the new system, the registry WHOIS simply contains information on which Registrar is authoritative for a given domain.

Verify Contact

As of January 1, 2014, ICANN requires all accredited registrars to verify your new contact information.

You can read about ICANN's new policy at:

In order to ensure your domain name remain active, upon the anniverary, modifications and any changes the contact must be verified. We are a reseller for OPENSRS and they likely will send an email to the contact like the picture below.

That email will have a link to a webpage that will have instructions. Failure to complete this process can eventually lead to the suspension of your domain name(s). As a reseller we are contacted prior to any suspensions of registrations that we resale and we do make reasonable efforts to work with the domain owner to avoid suspensions.

PLEASE BE AWARE that scams/phising email could be possible and some have <u>already been</u> reported [64] within days of the requirement by ICANN. So do carefully read any email that

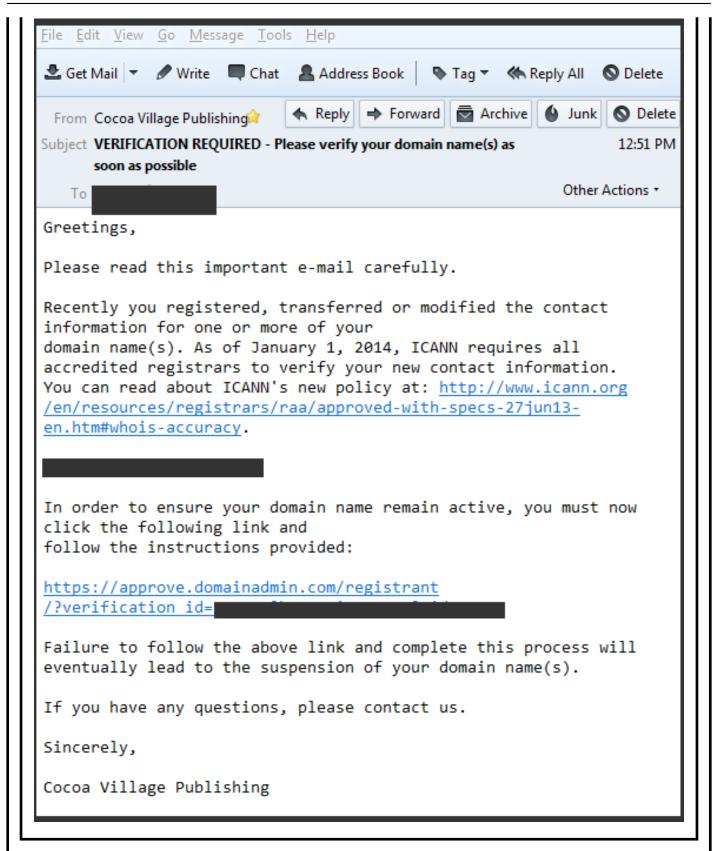
suggest links and may have attachments. If you are not sure the email is from us, or you have any questions, please contact us.

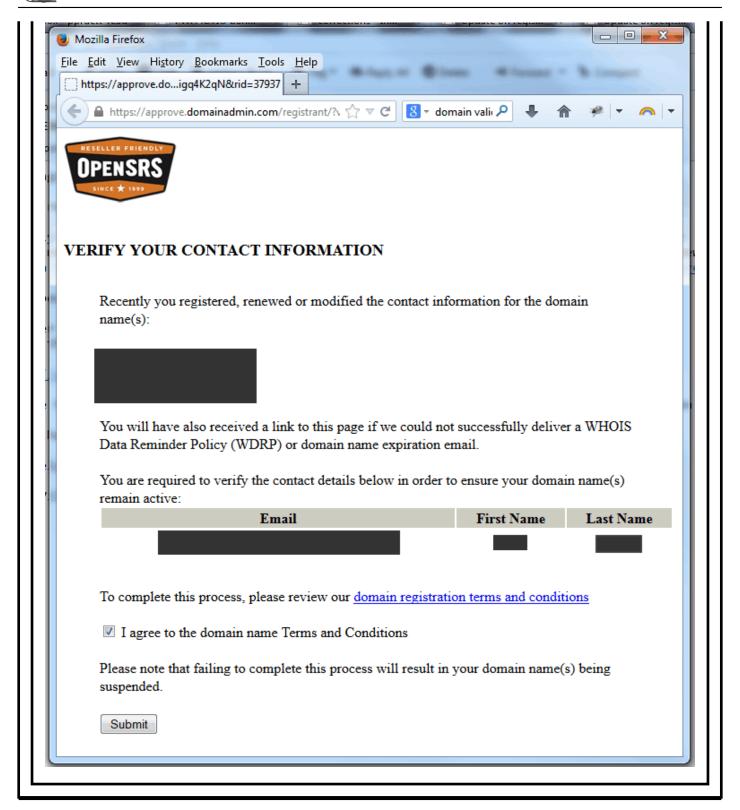

Internet Servers

We have computers that host web sites, web sites that support Microsoft Front Page extensions, ftp servers, mail gateways, mail list servers, sql servers, openIdap servers, and more.



Web Server [6]: We provide you a folder with space on our web server, more space available by option. The Web Site comes with an account which provides remote access and email addresses.

Microsoft FreetPage Extension for Web Server: The Microsoft FreetPage Extension Software can be added to the web server and configured to allow for convenient remote editing and support with Microsoft's Freet Page applications.

FTP Server [7]: We provide you a folder with space on our ftp servers, more space available by option. The FTP site comes with an account which provides remote access and email addresses (see price list for quantity). If the customer decides on the option of having their own internet, domain name, the ftp servers will support it.

<u>Mail Gateway</u> **[8]**: We support virtual electronic electronic mail services for customers who use our services to support their Internet domain name.

Mail List Servers [65]: We provide mail list services using the mail list program Mail Man, www.list.org [66] and mail server Sendmail. The mail list services allow the customer to maintain a mail list that individuals with electronic mail may subscribe, unsubscribe to. The Customer may elect to make the service open, restricted or moderated to postings by individuals. Digest services may be setup. A website interface is available to the customer to facilitate subscribing and un-subscribing to the mail list. We recommend that you consider the need to have two mail lists with one for only sending notices and another list that can receive notices and allow subscribers to reply. You may also select to moderate the lists. Please see the price list for options and additional details.

<u>Domain Name Servers</u> **[10]**: We provide Primary and Secondary Internet Domain Name Services, like registering and resolving <u>www.cocoavillage.com</u> [67]

<u>Specialized Servers</u> [68]: [69] We provide customized open source server solutions.

SQL Servers: We provide support for the open source SQL servers: MySQL [70] and PostgreSQL [71].

LDAP Server: We provide support for the open source LDAP server: OpenLDAP. [72]

Instant Messaging Server: We provide support for the open source JABBER server: <u>Jabber</u>. [73]

Custom Web Sites:

For estimating the price of custom web site design we determine the type and amount of professional time to create the web pages with the information you give us. The estimation of the type and amount of professional hours for a task is made by someone who is familiar with the service.

For a quote of a custom web site we will require a retainer fee which can be applied to the cost if we are asked to proceed. Because requirements may not be clearly defined or may change for custom work we may quote with milestones to allow mutual renegotiate between milestones if requirements change.

For the following packages we include the pricing for one year of service, Note prices are subject to change.

Business Card Website

This price includes the steps to make simple website with one page having the equivalent information that would be on a business card, the setup and support of a domain name, the labor to make it work, upto 5 email boxes or email forwarding and the website with business card information all for one year:

Price for setup:

One time fees: (\$88 office fee + \$3,520 website programming = \$3,608)

Note the setup is for the nominal training for customer and nominal graphics. The shopping cart software has user and adminstration interfaces. For example we can help setup 40 items with pictures, art and information provided by customer. Customer has authorization to modify, delete and add items. We are available to negotiate additional labor fees to do ongoing maintenance of inventory if customer prefers.

Recurring fees: (?? cost of digital certificate, geo-trust chained (wholesale) \$28.00, retail \$79, or verisign \$300+- no fee if self signed) + \$480 year website and *domain subscription = \$480.00 + certificate cost (estimate \$28) = \$508 Note the customer may select which certificate company to pay for.

Notes about credit cards and shopping Carts:

If you already have a credit card service you may wish to receive email notification of purchase and then hand process the purchase rather pay gateway fees necessary to process and get authorization code while customer is on the website. Setting up the shopping cart software to complete, batch, the sale will add complexity and labor and also require that your selected credit card service supports it without excessive customization, please call us about this with your questions.

Note that this pricing does not include the charges by the merchant service that you will contract with for processing credit cards. Prices for Credit Card Merchant Services vary, for example a nominal price **may be** around \$300 for setup and purchase of equipment/software and around \$0.30 per transaction, \$20 month for gateway fees, about 2.35% of purchases, and probably monthly minimums on fees of about \$35 so all together you can expect to spend to the credit card company around \$55/month even if no purchases are made. We do not assess these fees we only mention them here to give you nominal numbers to review when deciding on a merchant service.

Notes about credit cards and shopping Carts:
